Treasurer's Report (Dave Meredith)

James will inform all the clubs (that haven't done so) to send Dave invoices for scholarships.

- Dave will pay all scholarship invoices raised by the club and advise James of outstanding clubs that need to be contacted.
- Baccus March reimbursement for use of club facilities for instructor training.

Payment was agreed by all committee members via email and reconfirmed in the meeting by all members.

GFA Representative's Report (Bev Alden)

- -Insurance clarified from GFA that instructors are covered even if they are not members of the club they are instructing at.
- -Revising the funding model from the GFA to the regions. Some of the state's have substantial government funding, but all of the funding is already allocated and in line with the grants. The GFA is looking to implement a "fairer" distribution model. Phil notes that specific figures were put against specific items. Viv notes that the funding is a one off, not an ongoing source of funding and as such it would be unreasonable to restructure funding to the VSA as it can not be assured to remain. Phil notes that it is foundation funding to be an inclusive and sustainable organisation.
